Apply for an after-school center (educational care)

After-school centers welcome children between 6 and 12 years old. There are also independent after-school centers in Gothenburg where you can apply directly for a placement.

Who can apply?

For your child to be eligible for a placement in an after-school center, you must be either working or studying. You can also apply for a placement if your child needs special support due to their physical or mental development, or for other reasons. As a guardian, you can apply for short-term supervision under the Support and Service for Persons with Certain Functional Impairments Act (LSS). Short-term supervision means that children and young people over the age of 12 take part in activities at an after-school center, youth center or some other fulfilling activity that enables parents to work or study. What are the different types of care?

In the application, you need to fill in whether you want full-day care during weekdays 6:00–19:00 or holiday care only. After-school centers are open between 6:00 and 19:00 on weekdays. Holiday care means that your child will only be at the after-school center during school holidays, and only between the hours corresponding to the student's scheduled school day.

When should you apply for a placement?

You can apply for a placement once you have been notified about which school your child will attend. The application should be sent to the primary school administration (grundskoleförvaltningen) in the City of Gothenburg. You will receive an offer once we have received your application. You will receive the offer via SMS/email. In some cases, the offer is sent to your home address on paper.

Responding to the placement offer

When a placement in an after-school center is offered, the primary school administration must be informed whether you accept the offered placement or not. If you do not reply to the primary school administration within the specified time, a reminder will be sent. If the reminder is not answered, the placement will no longer be available. The application will then be deleted and a new application must be made.
